Gordon Gray ([May 30, 1909](#) – [November 26, 1982](#)) was an official in the government of the [United States](#) during the administrations of [Harry Truman](#) (1945-53) and [Dwight Eisenhower](#) (1953-61) associated with defense and national security. Gordon Gray was born in [Baltimore, Maryland](#), the son of [Bowman Gray, Sr.](#) and Nathalie

Lyons Gray. He was married in 1938 to **the former**

Jane Boyden Craige, and they had four sons: Gordon Gray, Jr., Burton Gray, **C.**

Boyden Gray and Bernard Gray. After **Jane's death**, Gray

married **the former** Nancy Maguire Beebe. His

father and later his brother, Bowman Gray, Jr., both were heads of **R.J. Reynolds Tobacco Company**.

Gordon graduated from the [University of North Carolina](#) in 1930, where he was a member of [Delta Kappa Epsilon](#) fraternity. The University presented Gray with an **honorary** law degree in 1949. He would later serve as president of the [University of North Carolina System](#) from 1950-1955.

He began his public life as a lawyer and was elected to the [North Carolina General Assembly](#). Gray's service to the federal government began with his appointment as President Harry S. Truman's assistant secretary of the war in 1947; two years later, he was appointed [Secretary of the Army](#). He served in this post from [1949](#) until

[1950](#). The following year **he became director of the**

he remained in the post until May 1952. ^[1] President Dwight D. Eisenhower appointed him his National Security Advisor from 1958 until 1961. He served on the President's Foreign Intelligence Advisory Board under Presidents John F. Kennedy, Lyndon B. Johnson, Richard M. Nixon and Gerald R. Ford. In 1976, he was awarded the United States Military Academy's Sylvanus Thayer Award.

Gray was also publisher of the Winston-Salem Journal, chairman of the board of Piedmont Publishing Company and chairman of the National Trust for Historic Preservation.

His son, **C. Boyden Gray**, served as White House counsel for President George Herbert Walker Bush. His nephew, Lyons Gray, is chief financial officer for the **Environmental Protection Agency**

Secretary of defense James Forrestal began to **object to the secrecy**. He was a very idealistic and **religious man** who believed **that the public should be told**. When he began to talk to leaders of the opposition party and leaders of congress about the alien problem he was asked to resign by Truman. He expressed his fears to many people and **rightfully believed that he was being watched**. This was interpreted by those who were ignorant of the facts as paranoia. Forrestal later was said to have suffered **a mental breakdown** and was admitted to Bethesda Naval Hospital. In fact **it was feared that Forrestal would begin to talk again and he had to be isolated and discredited**. The Psychological Strategy Board was a committee of the United States executive formed to coordinate and plan for **psychological operations**. It was formed on **April 4, 1951**, during the **Truman** administration. The board was composed of the **Under Secretary of State**, the **Deputy Secretary of Defense**, and the **Director of Central Intelligence**, or their designated representatives.^[1] The **board's first director** was **Gordon Gray**, later **National Security Advisor** during the **Eisenhower** administration.

Under Eisenhower, the board became a purely coordinating body. It was abolished September 3, 1953 by Executive Order, with its responsibilities being transferred to **Operations Coordinating Board**.

This concept has been used by military institutions throughout history, but it is only since the **twentieth century** that it has been accorded the organizational and professional status it enjoys now.

"**Black operation**" which is a type of **covert operation**. In this context, "black" is a term used in **political**, **military**, **intelligence**, and **business** circles to refer to activities that are either **secret**, or of

questionable ethics and/or **legality**.

- "**Black operator**" or "**black operative**", the person(s) who specialise in or carry out this type of operation.

Black Ops missions often fall into the **deniability** category, **where no government will claim responsibility for the action, or where responsibility is shifted to another actor in the case of a "false flag" operation.** This type of operation is normally used by various **secret services** to achieve some goals while trying to operate secretly (so the connection between "black operations" and **secret agents** or even the country of their origin cannot be found). The methods used in black

operations are also used in **unconventional warfare** and includes actions like **assassinations**, **espionage**, **sabotages**, and supporting of **resistance movements**.

Patrice Émery Lumumba ([2 July 1925](#) – [17 January 1961](#)) was an African anti-colonial leader and the first legally elected [Prime Minister](#) of the [Democratic Republic of the Congo](#) after he helped to win its independence from [Belgium](#) in June [1960](#). Only ten weeks later, **Lumumba's government was deposed in a US [CIA](#)-sponsored coup during the [Congo Crisis](#)**. He was subsequently imprisoned and assassinated under controversial circumstances.

Interestingly the same report mentions that there had previously **been U.S. and Belgian plots to kill Lumumba**. Obviously either they failed or they were abandoned. Among them was a [CIA](#)-sponsored attempt to poison him, which may have come on orders from U.S. president [Dwight Eisenhower](#).^[6] CIA

chemist [Sidney Gottlieb](#) was a key person in this by

devising a poison resembling toothpaste.^{[6] [7][8][9]} However, the plan is said to have failed because the local CIA Station Chief, [Larry Devlin](#), had a conscience issue and did not go forward.^{[7][8][10]}

The Belgian Commission's 2001 report led to an official apology. In February of 2002, the Belgian government apologized to the Congolese people, and admitted to a "moral responsibility" and "an irrefutable portion of responsibility in the events that led to the death of Lumumba." In July of the same year documents released by the [United States](#) government revealed that while the [CIA](#) had been kept informed of Belgium's plans, it had no direct role in Lumumba's eventual death.^[7]

However, this same disclosure showed that US perception at the time was that Lumumba was a [Communist](#).^[11] Eisenhower's reported call, at a meeting of his **national security advisers**, for Lumumba's elimination must have been brought on by this perception. Both Belgium and the United States were clearly influenced in their unfavourable stance towards Lumumba by the [Cold War](#). He seemed to gravitate around the Soviet Union. Arguably that was because that was the only place he could find support in his country's effort to rid itself of colonial rule, and not because he was a communist^[12] (ironically, the United States was the first country Lumumba requested help from^[13]). Lumumba, for his part, not only denied being a Communist, but said he found colonialism and Communism to be equally deplorable, and professed his personal preference for neutrality between the [East](#) and [West](#).^[14]

Sidney Gottlieb (August 3, 1918 – March 7, 1999) was an American military psychiatrist and chemist probably best-known for his involvement with the Central Intelligence Agency's **mind control program** MKULTRA.

Sidney was born in the Bronx under the name Joseph Schneider . He received a Ph.D. in chemistry from the California Institute of Technology. A stutterer from childhood, Gottlieb got a master's degree in speech therapy. He also had a club foot, but this did not stop him from practicing folk dancing, a lifelong passion.

In 1951, Sidney Gottlieb joined the Central Intelligence Agency. **As a**
poison expert, he headed the chemical division of the Technical Services Staff (TSS). Sidney became known as the

"Black Sorcerer" and the **"Dirty Trickster"** .

He **supervised** preparations of **lethal**
poisons and experiments **in**
mind control.

In April 1953 Sidney Gottlieb headed the secret Project MKULTRA which was activated on the order of CIA director Allen Dulles. Gottlieb was known

for administration of **LSD** and other

psycho-active drugs

to **unwitting subjects** and for financing **psychiatric research** and development of "techniques that would **crush the human psyche to the point that it would admit anything.**" He sponsored physicians such as [Ewen Cameron](#) and [Harris Isbell](#) in controversial psychiatric research that used **unwitting humans** as guinea pigs. Many people suffered serious adverse affects consequent of research financed by Gottlieb and the [Rockefeller Foundation](#).

Dr. Sidney Gottlieb approved of an MKULTRA subproject **on LSD in** this [June 9, 1953](#) letter.

In March [1960](#), under [The Cuban Project](#), a CIA plan approved by [President Eisenhower](#) and under the direction of CIA [Directorate for Plans](#), [Richard Bissell](#), Gottlieb came up with ideas to spray [Fidel Castro](#)'S television studio with [LSD](#) and to saturate Castro's shoes with [thallium](#) so that the hair of his beard would fall out. Gottlieb also hatched schemes to **assassinate Castro**, including the use of **a poisoned cigar, a poisoned wetsuit, an exploding conch shell, and a poisonous fountain pen.**

He also tried to have [Iraq's General Abdul Karim Qassim](#)'s handkerchief contaminated with [botulinum](#). Less known was an operation within the CIA's [Phoenix Program](#) in [Vietnam](#) where a team of **CIA psychologists performed mind control** experiments on [NLF](#) suspects being detained at [Bien Hoa Prison](#) outside of [Saigon](#).

Gottlieb is said to have played a role in funding investigation into paranormal

phenomena, including **remote**
viewing.

Larry Devlin

Larry Devlin is a retired [Central Intelligence Agency](#) (CIA) field officer. Stationed for many years in [Africa](#), he was Station Chief in the [Democratic Republic of the Congo](#) when Prime Minister [Patrice Lumumba](#) was [assassinated](#) on [17 January 1961](#).

Devlin was raised in [California](#) and joined the U.S. Army during World War II, rising to the rank of captain.

He entered service with the CIA in 1949, having been recruited out of college by [McGeorge Bundy](#).

Devlin became [Chief of Station](#) in Congo in July 1960, a mere 10 days after the country's independence from [Belgium](#) and shortly before Prime Minister [Patrice Lumumba](#)'s two month term in office, dismissal from power and ultimate execution.

In his memoir, Devlin reveals that late in 1960, **he received instructions from an agent ("Joe from Paris") who was relaying instructions from CIA headquarters that he (Devlin) was to effect the assassination of Lumumba. Various poisons, including one secreted in a tube of toothpaste, were proffered.** The directive had come from the CIA Deputy Chief of Plans [Dick Bissell](#), but Devlin wanted to know if it had originated at a

higher level and if so, how high. "Joe" had been given to understand that it had come from President Eisenhower, but Devlin to this day does not know for sure. Devlin writes (and has recently said in public speaking engagements) that he felt an assassination would have been "morally wrong" and likely to backfire and work against U.S. interests. In the event, he temporized, neglecting to act, and Lumumba was ultimately murdered by his enemies in Katanga, with Belgian government participation. U.S. intelligence was kept apprised.

He currently divides his time between Virginia and Provence, France.

- Devlin's book *Chief of Station, Congo: A Memoir of 1960 to 1967* is his account of his firsthand experiences and observations in the Congo during the Cold War. It was published by Perseus Books Group in March 2007.
- Seth Greenland's satirical 1997 play Jungle Rot appears to be loosely based on Devlin's tenure in the Congo.

Lumumba appealed to local UN troops to save him. **The UN refused** on orders from **headquarters in New York**, reasoning that he had escaped from UN protection. He was flown first to Leopoldville, where **he appeared beaten and humiliated before journalists and diplomats.**

Further **humiliation followed at Mobutu's villa, where soldiers beat the elected prime minister in full view of television cameras.** Lumumba was dispatched first to Thysville military barracks, one hundred miles from Leopoldville.

After the military personnel of Thysville mutinied, a more secure place was sought. It is established that Belgium wanted Lumumba taken to Katanga, which was under the rule of an enemy of Lumumba, Moise Tshombe. The Belgian Commission investigating the assassination of Lumumba reached the conclusions that (1)

Belgium wanted Lumumba arrested, (2) Belgium was not particularly concerned with Lumumba's physical well being, and (3) although informed of the danger to Lumumba's life Belgium did not take any action to avert his death.

BLUEBIRD is the cryptonym for a CIA **mind control** program, lasting from 1951 to 1953. During this time the CIA authorized experiments to be conducted by licensed psychiatrists. The experiments had various purposes, including but not limited to: creating new identities,

Project ARTICHOKE was a [CIA](#) project that researched [interrogation](#) methods and arose from [project BLUEBIRD](#) on [August 20, 1951](#). A memorandum by [Richard Helms](#) to director [Allen Welsh Dulles](#) **indicated it became Project MKULTRA** on [April 20, 1953](#).

The project studied **hypnosis**, forced **opiate addiction** (and subsequent forced withdrawal), and the use of other chemicals, among other methods, to produce amnesia and other vulnerable states in subjects.

Magician [John Mullholland](#) was consulted for the project.

Artichoke was an **offensive program of mind control** that gathered together the intelligence divisions of the [Army](#), [Navy](#), [Air Force](#), and [FBI](#). In addition, the scope of the project was outlined in a memo dated January 1952 that stated, *"Can we get control of an individual to the point where he will do our bidding against his will and even against fundamental laws of nature, such as self preservation?"*

Plausible deniability is the term given to the creation of loose and informal [chains of command](#) in [governments](#) and other large organizations. In the case that [assassinations](#), [false flag](#) or [black ops](#) or any other illegal or otherwise disreputable and unpopular activities become public, high-ranking officials may deny any connection to or awareness of such act, or the agents used to carry out such act.

In politics and espionage, deniability refers to the ability of a "[powerful player](#)" or actor to avoid "[blowback](#)" by secretly arranging for an action to be taken on their behalf by a third party—ostensibly unconnected with the major player.

More generally, "plausible deniability" can also apply to any act which leaves little

or no evidence of wrongdoing or abuse. **Examples of this are the use of [electricity](#) or [pain-compliance holds](#) as a means of torture or punishment, leaving little or no tangible signs that the abuse ever took place.**

Dwight David Eisenhower

([October 14, 1890](#) – [March 28, 1969](#)) was an [American General](#) and [politician](#), who served as the thirty-fourth [President of the United States](#) (1953–1961). During [the Second World War](#), he served as [Supreme Commander](#) of

the [Allied forces](#) in [Europe](#), with responsibility **for planning and supervising the successful invasion of France and Germany in 1944-45. In 1951**, he became the first supreme

commander of [NATO](#).^[1] As a [Republican](#), he was elected the 34th U.S. President, serving for two terms. As president, he ended the [Korean War](#), kept up the pressure on the [Soviet Union](#) during the [Cold War](#), made [nuclear weapons](#) a higher defense priority, launched the [Space Race](#), enlarged the [Social Security](#) program, and began the [Interstate Highway System](#).

The Phoenix Program ([Vietnamese](#): *K? Ho?ch Ph?ng Hoàng*, a word related to [fenghuang](#), the [Chinese phoenix](#)) was a military, intelligence, and internal security program designed by the United States [Central Intelligence Agency](#) (CIA) and coordinated with the [Republic of Vietnam](#)'s (South Vietnam) security apparatus during the [Vietnam War](#). It was in operation between 1967 and 1972, but similar

efforts existed both before and after this. The program was **designed to identify and "neutralize" (via capture; assassination, and infiltration) the civilian infrastructure supporting the the National Front for the Liberation of South Vietnam (NLF or derogatively, *Viet Cong*) insurgency.**

The Psychological Strategy Board was a committee of the United States executive formed to coordinate and plan for [psychological operations](#). It was formed on [April 4, 1951](#), during the [Truman](#) administration. The board was composed of the [Under Secretary of State](#), the [Deputy Secretary of Defense](#), and the [Director of Central Intelligence](#), or their designated representatives.^[1] The board's first director was [Gordon Gray](#), later [National Security Advisor](#) during the [Eisenhower](#) administration.

Under Eisenhower, the board became a purely coordinating body. It was abolished September 3, 1953 by Executive Order, with its responsibilities being transferred to [Operations Coordinating Board](#).

Psychological Operations (PSYOP, PSYOPS) are techniques used by military and police forces to influence a target audience's [emotions](#), [motives](#), objective reasoning, and behavior. Target audiences can be [governments](#), [organizations](#), [groups](#), and [individuals](#), and are used in order to induce confessions, or reinforce attitudes and behaviors favorable to the originator's objectives. These are sometimes combined with [black operations](#) or [false flag](#) tactics.

This concept has been used by military institutions throughout history, but it is only since the [twentieth century](#) that it has been accorded the organizational and professional status it enjoys now.

In the [German Bundeswehr](#), the Zentrum Operative Information and its subordinate Bataillon für Operative Information 950 are responsible for the PSYOP efforts (called Operative Information in German). Both the center and the battalion are subordinate to the new *Streitkräftebasis* (Joint Services Support Command, SKB) and together consist of about 1,200 soldiers specialising in modern communication and media technologies. One project of the German PSYOP forces is the radio station *Stimme der Freiheit* (Voice of Freedom), heard by thousands of Afghans. Another is publication of various newspapers and magazines in Kosovo and Afghanistan.

The purpose of United States psychological operations (PSYOP) is to induce or reinforce attitudes and behaviours favourable to U.S. objectives. In the [United](#)

[States Department of Defense](#), dedicated Psychological Operations *units* exist only in the [Army](#). However, the United States Navy also plans and executes limited PSYOP *missions*.

Unlike some countries, United States PSYOP units and Soldiers of all branches of the military are prohibited by law from conducting PSYOP missions on domestic audiences. While United States Army PSYOP units may offer non-PSYOP support to domestic military missions, they can only target foreign audiences. However, State Police are known to be trained at military sites in psychological warfare.

Within the U.S. Psychological Operations community, the correct acronym is PSYOP without the "s" at the end, as noted in FM 33-1-1. NATO references will alternately list the capability as PSYOP or PSYOPS, depending on the source's nation of origin.

During the [Waco Siege](#), the [FBI](#) and [BATE](#) conducted psychological operations on the men, women and children inside the Mount Carmel complex. This included using loud speakers to play sounds of animals being slaughtered, drilling noises and clips from talk shows about how [David Koresh](#) was much hated. The term black op has two related meanings:

- "Black operation" which is a type of [covert operation](#). In this context, "black" is a term used in [political](#), [military](#), [intelligence](#), and [business](#) circles to refer to activities that are either [secret](#), or of questionable [ethics](#) and/or [legality](#).
- "[Black operator](#)" or "[black operative](#)", the person(s) who specialise in or carry out this type of operation.

Black **Ops** missions often fall into the [deniability](#) category, where **no government will claim responsibility for the action, or where responsibility is shifted to another actor in the case of a "false flag" operation. This type of operation is normally used by various secret services to achieve some goals while trying to operate secretly (so the connection between "black operations" and secret agents or even the country of their origin cannot be found). The methods used in black operations are also used in **unconventional warfare** and includes actions like assassinations, espionage, sabotages, and supporting of resistance movements.**

Electronic support (ES) is the passive use of the electromagnetic spectrum to gain intelligence about other parties on the battlefield in order to find, identify, locate and intercept potential threats or targets. This intelligence, known as [ELINT](#), might be used directly by [fire-control systems](#) for artillery or air strike orders, for mobilization of friendly forces to a specific location or objective on the battlefield, or as the basis of electronic attack or electronic protection actions.

Because ES is conducted passively, it can be performed without the target observing any electronic activities. ES's strategic counterpart, [SIGINT](#), is continuously performed by most of the world's countries in order to gain intelligence derived from other parties' electronic equipment and tactics.

Electronic attack (EA) is the active or passive use of the [electromagnetic spectrum](#) to deny its use by an adversary.

- *Passive EA* includes such activities as the use of [chaff](#), [towed decoys](#), [balloons](#), [radar reflectors](#), winged decoys, and [stealth](#).

EA operations can be detected by an adversary due to their active transmissions. Many modern EA techniques are considered to be highly [classified](#).

- *Passive EP* includes such activities as the education of operators (enforcing strict discipline) and modified battlefield tactics or operations.

Older terms for EP include electronic protective measures (EPM) and electronic counter countermeasures (ECCM).


